ZOLVIX PLUS CHALLENGE PROMOTION

TERMS AND CONDITIONS

- Information on how to claim (including information contained in promotion materials) and the Kits form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Any claim that does not comply with these Terms and Conditions is invalid.
- 2. This Promotion is only open to Australian resident aged 18 years or over who are farmers/farm managers and managing a farm entity with a minimum of 2,000 sheep (referred to below as an "individual").
- This Promotion commences on 1 January 2025 and closes at 11:59pm AEDST on 31 December 2025 or once stock of Kits (defined below) has been exhausted, whichever is first ("Claim Period"). Provision of Kits is subject to availability within each region, while stocks last.
- 4. To participate in the promotion, individuals must register online at www.zolvixplusrewards.com.au during the Claim Period. Upon completing the registration, the following steps will occur:
 - a. A representative of the Promoter will contact the individual to confirm that they meet the minimum flock size and, if so, to discuss their current sheep drench program and provide directions on how to conduct a sheep DrenchCheck using their current drench;
 - b. The individual will then receive two (2) Elanco worm test kits (either directly from a representative of the Promoter or by post) (each a "Kit"). Each Kit will contain ten (10) sample jars, gloves, an order/authorisation form and a pre-paid express post bag;
 - c. During the Claim Period:
 - The individual must, up to ten (10) days before drenching, use the first Kit to collect ten (10) sheep faecal samples and dispatch the samples to the testing laboratory (as advised by the Promoter) using the pre-paid express post bag; and then
 - ii. 10-14 days after drenching, the individual must use the second Kit to collect another ten (10) sheep faecal samples and dispatch the samples to the testing laboratory (as advised by the Promoter) using the pre-paid express post bag.

Samples must be collected from sheep on the individual's farm. Any samples not collected from sheep will not be processed for testing. Samples will be tested for roundworms only.

Samples must be submitted to one of the testing laboratories advised by the Promoter only for processing.

- d. Once the samples have been received at the testing laboratory and undergone testing, the results of the tests will be provided to the Promoter (and, by participating in this Promotion, the individual agrees to the test results being provided by the laboratory to the Promoter). A representative of the Promoter will then contact the individual to discuss the sample results and provide recommendations on how to maintain or increase the effectiveness of the individual's drenching program. This will generally occur within twenty-one (21) days of the second Kit samples being received at the testing laboratory.
- 5. DrenchChecks and testing are dependent on the individual providing sufficient information and using Kits correctly and as intended. If insufficient or incorrect information is provided or Kits are not used correctly, then the samples will not be processed for testing and the individual will not be eligible for a DrenchCheck. Samples received after the Claim Period will not be processed for testing.
- 6. Only one (1) claim is permitted per farm entity.
- 7. Each Kit is valued at \$145; individuals will receive two Kits valued at \$290 in total. Such values are based on the current GYST Parasitology Services 2025 Price List for parasitology laboratory services. Kits are not transferable.
- 8. DrenchChecks provide a simple, fast and low-cost indication of possible drench resistance. As such, they should be viewed as a starting method to check for possible drench resistance. They do have limitations. Please see www.wormboss.com.au for more information. The Promoter is not responsible for, nor does it guarantee, testing results and drench resistance indications and is not responsible for (and shall not be held liable for) drench choice or timing of drench or production loss incurred in relation to same, as a result of this offer.
- 9. The Promoter reserves the right, at any time, to verify the validity of participants in the Promotion (including an individual's identity, age, place of residence, farm address and flock size) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the Promotion process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its
