

Elanco Chill and Fill Official Promotion Rules

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT
DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

VOID WHERE PROHIBITED

1. PROMOTION PERIODS. The Elanco Chill and Fill Promotion (“Promotion”), sponsored by Elanco US Inc. (“Sponsor”), will begin at 12:00:01 am Eastern Time (“ET”) on June 1, 2026, and ends at 11:59:59 pm ET on August 28, 2026 (the “Promotion Period”), and is subject to these binding official rules (“Official Rules”). This Promotion will be broken out into two (2) separate entry pools based on the status (i.e., either independently-owned or corporate-owned) of the Eligible Clinic (defined in Official Rule #2), as follows: (1) a national sweepstakes that is open to all independent and corporate owned Eligible Clinics as defined in Official Rule #2 (the “National Sweepstakes”); and (2) an early- bird sweepstakes that is only open to corporate owned Eligible Clinics (the “Early-Bird Sweepstakes”). **Please note:** when a corporate-owned Eligible Clinic submits an entry into the Promotion during the Early-Bird Entry Period, they are automatically entered into both the National Sweepstakes and the Early-Bird Sweepstakes simultaneously.

The Promotion Periods will consist of two (2) separate entry period periods: (1) the Early-Bird Sweepstakes begins at 12:00:01 AM ET on May 15, 2026 and ends at 11:59:59 PM ET on June 30, 2026 (“Early-Bird Entry Period”); and (2) the National Sweepstakes which coincides with the Promotion Period and will be separated into thirteen (13) separate weekly entry periods (each a “Weekly Period”), each beginning on Monday at 12:00:00 AM ET and ending at 11:59:59 PM ET on the following Sunday, as set forth in the National Sweepstakes Weekly Period, Drawing & Prize Chart listed below.

2. ELIGIBILITY. The Promotion is open only to independently-owned and the following corporate-owned veterinary clinics: Alliance, American Veterinary Group, Amerivet, Blue River, CareVet, Heart and Paw, Heartland, NVA, Petsmart Veterinary, SVP+MVP (Mision Pet Health), Thrive, United Veterinary Care, Vet Evolve, Vetco Total Care, Vetcor, Well Haven, Western Veterinary Partners that are located within the 50 United States and District of Columbia (excluding Alaska), who are authorized resellers of Sponsor’s products and have an account with Sponsor in good standing during the Promotion Period, as solely determined by Sponsor (each, an **“Eligible Clinic”**). This Promotion is not open to members of the general public, individuals, MARS, Military or University accounts. Void in AK and where prohibited. The entrant is the Eligible Clinic and not the individual submitting an entry. This Promotion, and all promotions relating thereto, are subject to all federal, state, and local laws and regulations. By participating, each Eligible Clinic agrees to abide by these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

3. HOW TO ENTER. This Promotion will be broken out into three (3) separate regions/areas, depending on where the Eligible Clinic entering is located. The three (3) regions are: West Region, Northeast Region, and Southeast Region (each, a **“Region”**). There are two (2) methods of entry into the Promotion: **(1) Auto Purchase Entry:** An Eligible Clinic, once Registered as set forth below, will automatically be entered into the National Sweepstakes and its Region’s Weekly Period’s random drawings, upon the issuance of a single purchase order of any tray of Elanco vaccines or Canine Parvovirus Monoclonal Antibody (CPMA) with Sponsor made during the any applicable Weekly Period. In addition, if the Eligible Clinic is corporate-owned and its purchase order is dated during the Early-Bird Entry Period, then such Eligible Clinic will also receive an entry into

its Regional Early-Bird Sweepstakes. Limit one (1) auto purchase entry per eligible purchase. **PLEASE NOTE REGISTRATION REQUIREMENT:** To be an eligible entry for the auto purchase method of entry, each Eligible Clinic must **first** visit www.Elancochillandfillsweepstakes.com (“Website”) and register their clinic by providing if the clinic is independently-owned or corporate-owned, the clinic name, address and telephone phone number (upon submission, each Eligible Clinic is then “Registered”).

OR (2) Mail-In Entry (“AMOE”): Alternatively, to enter without making a purchase, an Eligible Clinic may handprint/type the Eligible Clinic’s name, if the clinic is independently-owned or corporate-owned, a contact name, Eligible Clinics address, city, state and zip code, phone number and email address on a 3” x 5” card/paper, and mail in a first-class stamped envelope to: Elanco Chill and Fill Vaccine Promotion, PO Box 4006, Grand Rapids, MN 55730, to be postmarked by the End Date and received the day prior to the Random Drawing date as listed in the National Sweepstakes Weekly Period, Drawing & Prize Chart above for the National Sweepstakes; and to be postmarked by June 30, 2026 and received by July 7, 2026, to also receive an entry into the Early-Bird Sweepstakes simultaneously (for corporate-owned Eligible Clinics only). There is no limit to the number of mail-in entries a clinic may submit; however, each mail-in request must be mailed in a separate, postmarked envelope. Proof of submission is not proof of receipt by Sponsor. Sponsor’s computer will be the official timekeeper for purposes of this Promotion.

4. DRAWINGS AND PRIZES.

a. **For the National Sweepstakes:** On or about each Friday set forth in the National Sweepstakes Weekly Period, Drawing & Prize Chart above, one (1) Grand Prize winner will be selected per Region (for a total of three (3) Grand Prize winners in each Weekly Period and thirty-nine (39) Grand Prize winners during the entire Promotion Period) and five (5) First Prize winners will be selected per Region (for a total of fifteen (15) First Prize winners in each Weekly Period and one hundred ninety-five (195) First Prizes during the entire Promotion Period). Winners are selected at random by Administrator from all

eligible entries received in each Region's Weekly Period. Odds of winning in the National Sweepstakes depend upon number of eligible entries received in each Weekly Period. All non-winning entries from any Weekly Period WILL roll over to subsequent Weekly Period random drawings.

b. **For the Early-Bird Sweepstakes:** On or about July 17, 2026, four (4) Grand Prize winners will be selected per region (for a total of twelve (12) Grand Prize winners during the entire Early-Bird Entry Period). Winners are selected at random by Administrator from all eligible entries received during the Early-Bird Entry Period. Odds of winning depend upon number of eligible entries received during the entire Early-Bird Entry Period.

c. **Winner Notifications:** Potential winners selected must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Winners will be notified by phone or email seven (7) days following the applicable random drawing. A prospective winner may be required to have an officer or owner of the Eligible Clinic sign an affidavit of eligibility and release of liability and publicity (where permitted), and return same, properly executed, within five (5) days of issuance of prize notification, on behalf of the winning Eligible Clinic.

5. PRIZES AND APPROXIMATE RETAIL VALUES ("ARV"): **Fifty-one (51) Grand Prizes** (39 for the National Sweepstakes; and 12 for the Early-Bird Sweepstakes)- One (1) vaccine refrigerator awarded to the winning Eligible Clinic. ARV: \$4,844.84 each. **One hundred ninety-five (195) First Prizes** (in the National Sweepstakes only) – A Sponsor-specified backpack. ARV: \$80.00 each. The total ARV of all Prizes is \$403,086.84. Prizes are subject to the manufacturer's warranties and guarantees. No prize or cash substitutes allowed. Winners may not transfer a prize. Prize will be awarded to the winning Eligible Clinic and not to an individual. The Sponsor reserves the right to substitute a prize for one of equal or greater value should an event occur that renders a prize unavailable. Taxes on the prizes are the sole responsibility of the winner. Winner is responsible for any reporting to local, state, or federal entities regarding receipt of a prize or reporting the

prize in earnings. Winner is further responsible for understanding and adhering to any of the clinics' policies concerning participation in and receiving a prize or gift in promotion.

LIMIT ONE (1) PRIZE PER ELIGIBLE CLINIC DURING THE ENTIRE PROMOTION PERIOD.

6. DELIVERY OF PRIZES. The winners will be contacted by email and asked to verify the mailing address of the winning Eligible Clinic for shipment of the Prize ("Winner Verification"). The winners will then have two (2) weeks to respond to the Winner Verification message with the appropriate information. If the selected winner fails to reply to the Winner Verification message and provide the mailing information within the allotted two (2) weeks, it will result in disqualification, and an alternate winner may be selected at Sponsor's sole discretion from among all remaining entries.

7. LIMITATION OF LIABILITY. Sponsor is not responsible for any type of technical difficulty (including, but not limited to: network server issues, connection problems, failed phone, computer, or telephone transmission, any type of technical failure), postal difficulty (including, but not limited to: late, lost, stolen, mutilated, damaged, or postage-due mail), or any other type of error whether human, mechanical, or electronic in relation to the survey or the Promotion. Any type of defective entry will be automatically disqualified.

8. RELEASE. By receipt of any Promotion prize, the winner agrees to release and hold harmless Sponsor, promoters, any respective related companies of Sponsor and promoters, and each of their respective officers, directors, employees, agents and representatives from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of any prize. Each winner agrees, as a precondition for the receipt of any prize, to execute all releases and other documentation reasonably requested by Sponsor.

9. DISPUTES. Eligible Clinic agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Promotion or any prizes awarded shall be resolved individually, without resort to any form of class action; (2) any and all claims,

judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion but in no event attorneys' fees; and (3) under no circumstances will Eligible Clinic be permitted to obtain awards for and Eligible Clinic hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning these Official Rules, participants' rights and obligations, or Sponsor's rights and obligations shall be governed by the laws of the State of Indiana, without giving effect to any choice of law or conflict of law rules.

10. MODIFICATION, SUSPENSION AND TERMINATION. If for any reason this Promotion cannot be executed as planned, including but not limited to infection by virus, bugs, tampering, unauthorized intervention, fraud, technical failures, legal mandate, or any other causes beyond the control of Sponsor or Promotion Administrator that corrupt or affect the security, administration, integrity, fairness or proper conduct of this Promotion, or if this Promotion is compromised or becomes corrupted in any way, electronically or otherwise, Sponsor and/or Promotion Administrator reserves the right, in its sole discretion, to void suspect entries and/or modify, suspend and/or terminate this Promotion. If the Promotion is terminated before the stated end date of the Promotion Period, Sponsor reserves the right to accept no further entries and award no further prizes.

11. PUBLICITY. By accepting a prize, each winner agrees and consents to Sponsor releasing their identity/name to anyone requesting a list of prize winners and the use of his/her name, likeness, voice and/or biographical information (city and state of residence) for advertising, marketing, promotional and commercial purposes and for Promotion purposes in any media now known or hereafter invented without time or territorial limitations and without additional notice or compensation.

12. PRIVACY. Any personal information collected through this Promotion is subject to Sponsor's Privacy Policy located at <https://privacy.elanco.com/en-us>. By entering this Promotion, each Eligible Clinic agrees that the Sponsor, its agents and/or representatives may store, share and use the personal information Eligible Clinic submitted with Eligible Clinic's entry for the purpose of administering the Promotion and agrees to the collection, use and disclosure of his/her personal information as described in these Official Rules, in the above Privacy Policy and as permitted by law.

13. WINNERS LIST.
