## A. vasorum is the potentially fatal Lungworm parasite

Identification of infection can be challenging in practice due to diverse clinical presentations - from asymptomatic or subclinical infections to more life-threatening cardiorespiratory or neurological signs.<sup>3</sup> Despite the potential for such serious consequences, 79% of UK dog owners do not know that prevention of clinical disease can only be achieved through monthly treatment prescribed by their veterinary surgeon.<sup>4</sup>

### The Lungworm Map

The Elanco Lungworm Map allows you to check reported cases of lungworm in dogs, in your postcode area.

Over the last 15 years this has created a picture of the spread of lungworm in the UK and local risk levels. However, only reported cases are shown, meaning the figures may under represent the true number of cases as many may go unreported.

Lungworm is now found throughout much of the UK, but regular monthly treatment will protect the dogs from infection even during continued exposure to potential risks, such as infected snails and slugs.



#### Advocate effectively controls a range of internal and external parasites – 23 in total across dogs, cats and ferrets.

- Indicated for the treatment of GI nematodes including zoonotic *Toxocara canis* and *Toxocara cati*.
- Treatment of ear mites, sarcoptic mange and demodicosis.
- Additional indications for emerging parasites such as eye worm (*Thelazia callipaeda*).
