The Elanco Cattle Vaccine Promise[™] Terms and Conditions

Immunity and immunization are complex medical processes that are dependent upon many factors beyond the vaccine itself. No manufacturer can guarantee exactly how an animal will respond to a vaccine. However, Elanco US Inc. ("Elanco") guarantees how we support our customers. By enrolling in the Elanco Cattle Vaccine Promise ("Program"), the customer agrees to the following terms and conditions:

- 1/ The Program is only available to customers in the United States who are using vaccines from Elanco. Existing Elanco vaccine product customers qualify for the Program with purchase of a new Eligible Product that the customer has not used in the previous two years.
- 2/ The following Elanco vaccine products are eligible for the Program ("Eligible Products"): Bovine Pili Shield, Fusogard, Lepto Shield, Master Guard, NUPLURA PH, NUPLURA PH+, Pinkeye Shield, ReproSTAR, Scour Bos, Somnu Shield, Titanium, Vib Shield, Vira Shield.
- 3/ The following animal species are eligible for the Program ("Eligible Cattle"): bovine species.
- 4/ The customer must purchase the Eligible Product from an Elanco-approved supplier or licensed veterinarian, use the product according to label instructions, and maintain documentation of the Eligible Product purchase and treatment records, including other vaccines or medications administered to the cattle receiving the Eligible Product under the Program.
- 5/ To participate in the Program, the Program enrollment form must be received by Elanco from the customer prior to ordering the Eligible Product by the customer. Product purchased prior to the customer enrolling in the Program does not qualify for the Program.
- 6/ "Refund Eligible Product" is (1) a product that the customer has purchased and used according to the terms and conditions of the Program for the Eligible Cattle; (2) the customer has submitted to Elanco the Elanco Cattle Vaccine Promise Satisfaction Guarantee Claim Form ("Claim Form") within six (6) months of the purchase date of the Eligible Product by completing all fields required by the Claim Form and providing all information required by the Claim Form; and (3) Elanco has verified the completeness and accuracy of the information received as part of the Claim Form. Contact your Elanco representative or call 1-800-428-4441 for help with completing the Claim Form.
- 7/ The Elanco Cattle Vaccine Promise Refund ("Program Refund") is as follows: (1) for any unused product, the customer will receive a refund of the full price the customer paid for the Refund Eligible Product; and/or (2) for any used product, the customer will receive a refund of 50% of the price paid by the customer for the Refund Eligible Product.

- 8/ The Program Refund does not apply to products received free of charge.
- 9/ All package sizes of the Eligible Products qualify for the Program Refund.
- 10/ The customer must provide proof of purchase of the Eligible Product to receive the Program Refund.
- 11/ Elanco reserves the right to perform an adverse event and/or disease diagnostic investigation at Elanco's expense. The customer agrees to cooperate with Elanco, provide Elanco with the information requested by Elanco and with access for Elanco staff to the customer facility and the affected cattle if requested by Elanco.
- 12/ Elanco reserves the right to withhold the Program Refund request based on incomplete or incorrect information, and/or the customer's failure to follow the terms and conditions of the Program.
- 13/ The Program does not apply to and Elanco shall not be liable for (1) off-label usage of the product; (2) any damages caused as a result of the improper handling, misuse or abuse of the product; (3) the willful misconduct or negligence of any third party; and/or (4) any indirect, punitive, special, incidental or consequential damages.
- 14/ Program Refund, as described in the Program terms and conditions, is the sole and exclusive remedy for any and all customer claims related to the Program. Elanco's liability is limited to the value of the products purchased by the customer, excluding the products received by the customer free of charge, and as limited by the Program Refund.
