Environmental Statements:	ENVIRONMENTAL PROTECTION: Use tags only on cattle. DO NOT contaminate streams, rivers or waterways with the tags or used containers.
Disposal:	Do not dispose of unused ear tags on-site. Break, crush, or puncture container and deliver containers and spent tags to an approved waste management facility. If an approved waste management facility is not available, bury the broken, crushed or punctured containers and spent tags 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.
Storage:	Store below 30°C (room temperature). Store in original container in a dry, cool place. DO NOT store in direct sunlight.

Dosage and Administration:

For control of Buffalo Flies attach one tag per animal to the back of the ear. Patriot Insecticide Ear Tag for Cattle will give effective control of Buffalo Flies if used regularly on all animals (over 3 months of age). The treatment regime will also reduce the potential for Diazinon resistance to develop. Apply tags as shown in Figures 1-4.
