MULTIBOOST™ ELANCO TOOLBOX PROMOTION 2026 PARTICIPATING CLINIC TERMS AND CONDITIONS FOR PARTICIPANTS

The Promoter

1. The promoter is the participating New Zealand Veterinary Clinic (Promoter).

Terms and Conditions of Entry

2. Information on how to enter the MultiBoost Elanco Toolbox Promotion 2026 (Promotion) and the Prize form part of these terms and conditions.
3. Entry into the Promotion is deemed acceptance of these and any other applicable terms and conditions (together Terms and Conditions). Any entry not complying with the Terms and Conditions is invalid.

How to Enter and Eligibility

4. The Promotion is open to New Zealand residents who are aged 18 years or over (Participant) who purchase any MultiBoost™ or MultiBoost™ with B12 500mL pack (Eligible Product) from the Promoter during the Promotion Period (defined below).
5. Employees and directors of the Promoter, and the immediate families of employees and directors of the Promoter, are not eligible to enter.
6. To enter the Promotion, Participants must, in a single transaction, purchase any Eligible Product(s) from the Promoter during the Promotion Period, and enter their required details at the time of completing their transaction in the official Promotion entry form and providing it to the Promoter at such time (Qualifying Transaction). Proof of purchase must be retained by the Participant.
7. Multiple entries are permitted provided each is a Qualifying Transaction (with a separate completed Promotion entry form).
8. The Promoter accepts no responsibility for any entries that are incomplete, illegible, corrupted or fail to reach the Promoter for any reason by the relevant Closing Time and Date (defined below). Such entries will be deemed invalid.
9. The Promoter reserves the right to verify the validity of entries and a Participant's eligibility (including identity, age, and place of residence) at any time. In case of a dispute regarding identity or eligibility, the Promoter's decision is final. The Promoter may disqualify any Participant who submits an entry not strictly in accordance with these Terms and Conditions or who tampers with the entry process.

Promotion Details

10. The Promotion commences at 8am on 16th March 2026 and closes at 5pm on 31st May 2026 (Closing Time and Date) (Promotion Period). Entries must be received by the Promoter during the Promotion Period and by the Closing Time and Date.
11. The Prize(s) draw will take place at the Promoter's clinic on (or around) 1st June 2026 (Draw Date). The Promoter may draw additional reserve entries. The Prize-winner(s) (Prize-winner(s)) will be drawn randomly and will be the first eligible entry drawn (or if there is more than one Prize, the first and second, etc).
12. The Prize-winner(s) will be contacted by the Promoter (or their agent) within two (2) business days of the Draw Date by telephone or email using the contact details provided by the Participant on the Promotion entry form. (A business day means a day that is not a Saturday, Sunday nor a public holiday in New Zealand.)
13. The Promoter shall arrange with the Prize-winner(s) for them to collect the Prize from the Promoter.
14. If a Prize is unclaimed because a Prize-winner cannot be contacted within fifteen (15) business days following the Draw Date, or if the Promoter determines a Prize-winner is ineligible, the Prize may, at the Promoter's sole discretion, be forfeited and redrawn (or, if reserve winning entries were obtained, provided to the next additional reserve winning entry). The Promoter is not responsible if the Prize-winner cannot be contacted within this timeframe.
15. If the Promotion is interfered with or cannot be conducted as anticipated due to reasons beyond the Promoter's control, the Promoter reserves the right, to the fullest extent permitted by law, to: (a) disqualify any Participant; or (b) modify, suspend, terminate or cancel the Promotion, as deemed appropriate.
16. In the event of war, terrorism, state of emergency, pandemic or any other disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the Promotion or suspend, substitute or modify a Prize, subject to any written directions from a relevant regulatory authority (where applicable).

Prize(s)

17. The prize is a ToolShed branded Tool chest, and toolset, valued at NZD\$1,030 (Prize). There is at least one Prize to be won, but the Participating Clinic may have more than one Prize available.
18. Prizes, or any unused portion of a Prize, cannot be exchanged, negotiated, transferred or redeemed for cash, unless otherwise specified. If the Prize (or any part of a Prize) is unavailable for any reason, the Promoter reserves the right to substitute the Prize or part of the Prize with a prize of equal value and/or specification.
19. The Promoter's decision on all matters will be final and no correspondence will be entered into.

Data Protection

20. By participating in the Promotion and providing the Promoter with Personal Information a Participant consents to use of the Personal Information as set out in these Terms.
21. The information submitted to the Promoter, and its subcontractors or agents, for the Promotion contains data that allows the Participant to be identified, including name, address, and phone number (Personal Information). If a Participant declines to provide their Personal Information, they will not be eligible to participate in the Promotion or receive a Prize.
22. The Promoter, its subcontractors, and agents, will process the Personal Information to administer the Promotion and to notify a Participant if they are a Prize-winner.
23. Prize-winners consent to the Promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media (including social media posts) for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any Elanco products manufactured, distributed and/or supplied by the Promoter.

Limitation of liability

24. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Fair Trading Act 1986, as well as any other implied warranties under the Consumer Guarantees Act 1993 or similar consumer protection laws in New Zealand (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any cost, expense, personal injury, loss or damage (including loss of opportunity and loss of profits); whether direct, indirect, special or consequential, arising in any way out of the Promotion including, but not limited to, where such liability may arise out of the following:
 - (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
 - (b) any theft, unauthorised access or third party interference;
 - (c) any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after its receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
 - (d) any variation in Prize value to that stated in the Terms and Conditions;
 - (e) any tax liability incurred by a Prize-winner or Participant; or
 - (f) use of the Prize by a Prize-winner and any accompanying person or any other person.
25. The Participant releases the social media platform(s) and its/their associated companies from all liability arising in respect of the Promotion and acknowledges that:
 - (a) the Promotion is in no way sponsored, endorsed or administered by, or associated with, any social media platform;

- (c) any questions, comments or complaints regarding the Promotion will be directed to the Promoter, not to any social media platform.

General

These Terms and Conditions are governed by the laws of New Zealand and any dispute arising out of or in connection with them will be subject to the exclusive jurisdiction of the courts of New Zealand.
